Minimum Wage

Arizona's minimum wage rate is \$10.00/hour, and its tipped (or sub-minimum) wage rate is \$7.00/hour, under a 2016 ballot initiative.⁸ More than half of all minimum wage or below-minimum wage workers in Arizona are women.⁹
