Minimum Wage

Maine's minimum wage rate is \$9.00/hour, and its tipped (or sub-minimum) wage rate is \$5.00/hour, under a 2016 ballot initiative.⁸ About six in ten of all minimum wage or below-minimum wage workers in Maine are women.⁹
