
Demographic Change in American Life












The Latino vote will double in 20 years



Overlap in the RAE

- As the previous slides indicate, Latinos, African Americans and Asian Americans are all relatively YOUNGER
- Unmarried women are more likely to be non-White, under 40 and city dwellers
- While they are growing, the RAE is also comparatively <u>newer to the political process</u>, and have less established voting patterns

Political Baptism

- RAE is an electorate at a critical juncture political behavior is forged in moments of political baptism
 - "The act of voting is self-reinforcing; when they vote, they become more likely vote again. Voting and abstention, in other words, are habit forming." (Gerber et. al. 2003)
 - If a group of voters demonstrate sustained political behavior for three consecutive cycles, it is very hard to turn back. (Fiorina 1977; Sears & Valentino 1997)



Overall there are 12 states where RAE vote was directly influential in Presidential outcome in 2012 accounting for 146 E.C. votes






